VIP ROOM

The Toppling Goliath VIP room is ideal for business meetings, small social or family gatherings, game-day parties, or for club or organizational meetings, offering a behind-the-scenes view to the brewery. This space comfortably seats up to 12 people and is equipped with a farm table plus casual seating options. Food and beverage services are available upon request. The VIP space is equipped with an HDMI TV with a simple plug-n-play set-up for Powerpoint or other presentations.

MEZZANINE

The mezzanine offers a semi-private space with the taproom feel! Ideal for groups of 30 or more people, the mezzanine features windows to the brewery and overlooks the taproom - a loft, so to speak. The area includes a lounge space, television screens for presentations or entertainment, and private restroom facilities. It is accessible by stairs only - two flights of about ten stairs each. We do not have an elevator. If this presents an issue for you or a guest, please inquire with the events manager for possible alternative options.

OUTDOOR TENT

During the warmer months in Iowa, guests enjoy spending time outdoors at Toppling Goliath. Our on-site canopy tent, situated next to the patio, offers a relaxed setting for gatherings. In addition, we offers dedicated buffet-style food services and beverage options for guests who choose to rent the tent.

FOOD & DRINK SERVICES

Pricing for the use of the event spaces is determined by guest count and catering selections, rather than a flat rental fee. A rental fee will only be applicable for groups of fewer than 30 guests who require a private space or if your event exceeds 4 hours. We are delighted to provide you with a variety of options to enhance your experience with us. Our offerings include a full catering menu, draft and cocktail menu, and even brewery tours. We would be delighted to offer trivia or bingo as entertainment for your event. In addition to the food costs, any add-ons such as entertainment, equipment, or merchandise will be added to one master bill, which will be payable on the date of the event. As for drinks, you have the flexibility to choose from options such as an open bar, cash bar, or the use of drink tickets covered by the master tab and the remaining rounds paid individually. Regarding tours, you can choose to handle the payments separately or include them in the master bill. Please note that all open tabs and the master bill (including sales tax and a minimum gratuity of 20%) must be settled at the conclusion of the event with the event lead.

DRINK POLICIES

The Toppling Goliath mezzanine features a private bar with eight taps from which Toppling Goliath beers will flow. Our event manager will determine the tap list, ensuring that the most popular beers are offered, as well as a variety of beer styles and rotational brands. In addition to the taps offered through the private bar, your guests will have access to all beers on the current draft list.

We are pleased to offer a variety of beverage options, in addition to our draft menu, including cocktails, wines, ciders, and non-alcoholic beverages.

We kindly ask that you refrain from bringing any outside beverages, including wine, spirits, or other drinks. If any outside beverages are found in your possession, they will be confiscated.

FOOD POLICIES

All food is catered in-house. Outside food is not allowed, except for specialty cakes which require prior approval.

DECORATIONS

We provide black or white linens upon request at no extra cost to you. In most cases, you will have access to the space one hour before your event begins. During this time, you are allowed to decorate or rearrange the space as long as you avoid using duct tape, nails, or adhesive-back strips on the walls, floors, or ceilings. Please refrain from using glitter, glitter balloons, confetti, or ceiling draping. If you are interested in renting decor, the event manager can assist in coordinating this for you.

SPECIAL EQUIPMENT

Our equipment options include speakers, microphones, projectors, screens, and TVs that can be connected to a laptop for presentations. Rental fees for any special equipment arranged through Toppling Goliath will be included in your final invoice and must be paid on the day of the event.

ACCESS TO EVENT SPACE

You will typically have access to the event space for set-up purposes one hour prior to your event, unless other arrangements have been made with the event manager. Please feel free to contact us if you would like to view the space before finalizing your booking.

BOOKING & DETAILS

We strive to ensure the success of your event. To facilitate this, we kindly request that all menu details be confirmed at least two weeks prior to the event date. The food charges will be based on the final guest count, so it is important to provide an accurate number. If the confirmed guest count is not received within 7 business days of the event, the count provided at the time of booking will be used.

If any guests have special dietary requirements, please inform the event manager in advance so that accommodations can be made and noted on the master bill.

If you plan to offer drink tickets for your guests, please confirm the number of tickets needed for redemption upon confirming the final guest count.

CANCELLATION POLICY

We understand that things happen and cancellations are sometimes unavoidable. If cancellation occurs more than 2 weeks prior to the event, no cancellation fee will be incurred. However, if cancellation takes place within 2 weeks of the event, a fee of \$100.00 per hour for the original, agreed upon duration of the event will be applied.
